Once tallied, the unofficial results will be posted to the website elections@whitecountyttn.gov as soon as all polling locations have returned to the courthouse.

The Election Commission will meet at 9:00a.m. November 6th to conduct the optical scan audit and voter registration inspection.

The Provisional Counting Board will meet at 5:00p.m. on November 9th to review all provisional ballots.

The Election Commission will meet at 5:00p.m. on November 17th to Certify the Election.

The Election Commission will also address any other pertinent business and allow time for Public Comment at all meetings.

ATTENTION CANDIDATES: Display of campaign posters, signs or other campaign materials, distribution of campaign materials and solicitation of votes is strictly prohibited within 100 feet of any polling place entrance. TCA 2-7-111. During the hours the polls are open, candidates are not to enter a polling place unless they are there to cast their ballot.
